

## Nonimmigrant Schedule of Fees

**Please keep a copy of this sheet for your records.** The Board establishes financial policies. There will be no variance from the policies set by the Board without written authorization from the principal.

**Method of payment:** Invoices may be paid through PayPal or personal check. Payment must be in US Currency. A surcharge of 3% will be added to the PayPal invoice. The school does not receive money transfers. International transfer fee is \$150. Cash payments are accepted, but a \$2 per \$1,000s is added to recover our costs.

### Explanation of Fees:

1. **Form I-20 Fees:** This one-time fee covers all federal document production and management during your student's time in the school.
2. **ESL on-line class:** The school may utilize online programs and pass the cost on to the student.
3. **Form I-901 Fees:** This money is sent to the Federal government; the receipt is attached to the Form I-20.
4. **Deferrals:** It may be possible to defer the student's start date. The charge for a deferral is \$500.
5. **Registration Fee:** This fee covers new student records costs.
6. **Educational Fee:** This fee provides for one set of books for a student. Students using multiple grade levels will be charged for additional books. The school retains ownership of all books, but at the end of the academic year, students may remove consumable textbooks assigned to them. A materials fee may be added to some classes. Books damaged beyond normal wear will result in charges.
7. **Tuition:** SEVIS students or students attending on a visitor's visa must pre-pay for the academic year or the remaining portion of the academic year before attending classes.
8. **Deposit:** Returning SEVIS students must pay a nonrefundable tuition deposit of \$1000 that is payable with the returning student's registration form. Returning students must secure their place in the school in January.
9. **Off-Campus Learning:** Off-campus learning experiences are a required part of an accredited educational program. The costs of these off-campus learning experiences are borne by all students enrolled in the participating classes. The cost for this program is \$400 per year.
10. **ELL Surcharge:** Not proficient students pay a non-refundable surcharge until they are determined to be proficient by the school. Once a student is proficient, this fee is dropped the next school year.
11. **Other Charges:** Nonimmigrant students must pay for other fees that all students pay, such as lunch tickets, school fieldtrip charges, piano classes, art programs, and before and after school care. Nonimmigrant students must also reimburse the school for specific charges the school incurs that are directly tied to the nonimmigrant student's involvement with the school, such as FED EX mail service, trips to the airport, or trips to meet with immigration officials.

**Refunds: The school does not provide for the return of ANY monies paid.**
